#### **Location and Description**

The land is approximately 2 miles east of Morton on the south side of North Drove. It is classified Grade 2 on the former MAFF Agricultural Land Classification Chart and is described as being of marine alluvium geology by the Soil Survey of England and Wales. The land has been farmed as one together with the field to the south for many years and so the southern boundary may need delineating by marker posts after harvest 2025.

In recent times there has also been a grass margin (SW1) extending to 0.56 ha (1.38 acres).

#### **Tenure and possession**

The land is available to let on a five year Farm Business Tenancy agreement with effect from 11 October 2025 with the rent to be payable half yearly in advance on 11 October and 6 April. The tenancy agreement will be based on a standard one produced by the Lincolnshire Association of Agricultural Valuers.

Early entry may be available subject to the completion of the letting formalities.

#### **Tenantright and dilapidations**

No claim for tenantright is anticipated from the outgoing tenant but the landlord reserves the right to recover any tenantright that may be payable from the new tenant.

Similarly it is not anticipated that any claim for dilapidations by the landlord will be required or appropriate on termination of the current tenancy.

#### **Outgoings**

Drainage rates are payable to the Black Sluice Internal Drainage Board.

#### Rural Payment Agency/Agricultural Subsides

The land is registered with the Rural Payments Agency. The new tenant will not be required to continue with the grass margin.
